The Club reserves the right to refuse booth space to, or to eject, any vendor whose behavior has caused problems with exhibitors, spectators, or show management. Vendor space fees are non-refundable.

THUNDERKATZ VENDOR CONTRACT

All sales activity AND free giveaways must be conducted in the vendor's booth area. No vending from the benching area! All sales activities are subject to the approval of show management. Personal auctions and/or raffle tables will not be allowed. Vendors are expected to donate one item for the club raffle.

INSTALLATION AND REMOVAL OF BOOTHS: All booths must be fully operational by 9:00 am on Saturday, July 2, 2022. Booths must remain intact and manned until the end of advertised show hours (approximately 4:00 p.m. on Sunday, July 3rd).

SECURITY: Security will not be provided for the show. Neither ThunderKatz Cat Club, nor The Payne County Expo Center, nor TICA will be liable for any loss of merchandise, cash, or injury to persons. Vendors are encouraged to take precautions concerning loss and/or damage and encouraged to arrange for any desired insurance coverage prior to the show.

PROPERTY DAMAGE: Vendors shall be liable for any damage to the show facility caused by them, their employees or their representatives. Nothing shall be tacked, nailed, screwed, or otherwise attached to walls, columns, floors or other parts of the building or furniture.

The undersigned Vendor agrees to abide by all terms and requirements listed in the included "VENDOR INFORMATION SHEET", as well as all terms set forth on these pages. Vendor must provide all equipment, labor and fixtures beyond that stated in this agreement. All fees must be paid before Vendor will be allowed to set up. Additionally, the undersigned Vendor agrees to indemnify and hold the Club, the State of Oklahoma, the City of Stillwater, The Payne County Expo Center, Payne County, and their respective members, agents, officers, servants and employees harmless from and against any claims relating directly or indirectly to the use of the space allocated to Vendor, including, and without limitation, actions of the Vendor in setting up and tearing down Vendor's booth space and/or loss due to theft or breakage.
